

At Keresley Grange we are proud of our children and their achievements. We want all of our children to be successful in all they do and have a growth mind-set; enjoying challenge and realising that they can achieve anything if they put their mind to it and put in 100% effort. We closely monitor the progress and attainment of all of our children as well as particular groups. One of these groups is our pupil premium children.

The pupil premium grant is funding provided to schools to help all pupils reach their full potential, regardless of their background or financial situation.

The pupil premium is not used to pay for school meals. Schools use the funding to improve the attainment of pupils who are eligible.

Each pupil **from Reception to year 6** who has been granted the pupil premium receives free school meals.

The school receives £1,320 additional funding for each of these pupils.

The school receives £2,300 additional funding for our 'Looked after children' and for those who have ceased to be looked after by a local authority in England and Wales because of adoption, a special guardianship order, a child arrangements order or a residence order.

These are some of the ways we use our funding:

- Growth mind-set training for all pupils, particularly focusing on Pupil premium.
- Small group Forest schools sessions.
- Thrive support emotional and social development
- Nurture sessions offering care, guidance and support.
- Additional opportunities to enrich learning, such as through poetry workshops, Archery sessions and Family Swim sessions.
- Residential stay subsidies.
- Assessment tracking systems.
- Personalised learning interventions.
- Focused Teaching Assistant Support.
- Reduction in costs of Grangers sessions.
- Reward systems for improved attendance.

 - Until 1 April 2018, all UC claims were eligible for free school meals, however,
 - From 1 April 2018, UC claims will only be eligible for free school meals if the total net **earned** income is under £7,400 per year OR if the child was eligible for a free school meal on 01/04/18



Language, Learning, Lives

- Where the child was eligible for a free school meal on 01 April 2018, they will remain entitled to a free school meal, regardless of any change in parental income until they finish the phase of education they are in (primary or secondary) as at 31 March 2022.
- Any child who becomes eligible for a free school meal between 01 April 2018 and 31 March 2022 will remain entitled to a free school meal, regardless of any change in parental income until they finish the phase of education they are in (primary or secondary) as at 31 March 2022.
- Support under part V1 of the Immigration and Asylum Act 1999
- Child Tax Credit, provided they are not entitled to Working Tax Credit and have a total annual income (as assessed by HM Revenue & Customs) that does not exceed £16,190
